Key steps for countries to engage with the Fund

 Establish and maintain a National Designated Authority (NDA) or focal point


 Strategic engagement through country programmes (optional)

 Identify and seek accreditation of entities to access resources from the Fund

 Develop projects and programmes to bring forward funding proposals through accredited entities



Summary of Readiness Activities



Activity Area 1: Strengthening NDA

Build capacity undertake key **functions**

Recommend funding proposals based on country strategies/plans, including consultation'

Facilitate communication of nominations of prospective entities seeking accreditation

Seek to ensure consistency of funding proposals from all entities with national plans and strategies

Implement the no-objection procedure

Act as focal point for communication with the fund

Undertake ongoing engagement of stakeholders at National and subnational level, including government, CSOs and private sector

Activity Area 2: Strategic Framework & Country Programme

Distilling a country programme and pipeline of concepts

Developing a country programme that identifies strategic priorities for engagement with the Fund, disseminating information and engaging stakeholders in the country programme

Identifying strategic investment priorities and taking stock of existing strategies, policies, and needs assessments, including low-emission development strategies, Nationally Appropriate Mitigation Actions, National Adaptation Plans, and National Adaptation Programs of Action.

Activity Area 3: Accreditation

Distilling a country programme and pipeline of concepts

Raising awareness of the Fund's accreditation process, fiduciary standards and environmental and social safeguards (ESS)

Understanding the roles of existing institutions and identifying potential IEs and intermediaries

Conducting an institutional gap analysis of potential applicants against the fiduciary standards and ESS

Developing and implementing a personalized readiness and preparatory support plan that will support applicant institutions to address identified gaps in order to comply with the fiduciary standards and ESS (may include development of new policies and procedures)

Enabling lesson-learning from other institutions that have been through similar accreditation processes.

Activity Area 4: Project Preparation

Developing Projects

Identification of programmes and projects that advance national priorities and align with the results management framework of the Fund, including support for ensuring appropriate enabling investment conditions for specific projects or programmes Project and/or programme preparation

Risk assessments including technical, institutional, operational, financial, social and environmental components;

Identification of programme and project level indicators aligned with the results management framework of the Fund, and support for the monitoring and evaluation of impacts.
